Jim Connolly is the Vice President of Environmental, Health and Safety for Wheelabrator Technologies. Wheelabrator is focused on meeting the waste disposal needs of our communities and customers while delivering clean, renewable power to local communities. Wheelabrator is owned by energy-focused private equity firm, Energy Capital Partners (ECP).
