Judith joined Customized Energy Solutions from Massachusetts-based clean energy technology company, Beacon Power LLC, where she served as Vice President of Asset Management and Market Development. As a nationally recognized expert on energy storage, Judith has participated in numerous hearings and technical conferences at the Federal Energy Regulatory Commission and the U.S. Department of Energy.

Judson chairs the Massachusetts Energy Efficiency Advisory Council and represents Massachusetts on the Boards of the Regional Greenhouse Gas Initiative Inc.; and Massachusetts Clean Energy Center.

Previously Judith served as Chairman and Commissioner of the Massachusetts Public Utilities Commission during the Romney Administration. She holds an M.B.A. from Harvard Business School and a Bachelor's degree in Mechanical Engineering from Kettering University.

Nick Connors is the Director of the Green Communities Division at the Department of Energy Resources. The division provides grants, technical assistance and local support to assist municipalities in reducing energy use and costs by implementing clean energy projects in municipal buildings. Nick previously held the role of Director of External Affairs & Partnerships at the Department of Conservation and Recreation. Prior to that Nick led public affairs and communications efforts in political campaigns, in higher ed and with a public relations firm in Boston. Nick has spent more than 15 years working to develop successful coalitions through outreach, education and targeted engagement across private industry and including federal, state and municipal government. Eric Friedman is the Director of the Massachusetts Leading by Example Program (LBE), a “Greening the Government” effort established by a 2007 Executive Order. LBE works with all state government entities to identify, plan, and implement clean energy and sustainability actions across hundreds of state facilities, ranging from large college campuses, state hospitals and prisons, to small visitor centers and seasonal park facilities. Friedman led the effort to develop a green building standard for new government buildings, created state government’s first greenhouse gas inventory, and led the team that established a mandatory Computer Power Management Standard. Eric successfully oversaw the development and implementation of \$54.9 million worth of stimulus clean energy projects and was the state’s staff lead for the 2009 Zero Net Energy Buildings Task Force. Prior to his current position, Friedman managed the state’s first environmental purchasing program at the Massachusetts’ Department of Procurement and General Services (now the Operational Services Division). He has a M.A in Environmental Policy from Tufts University and a B.A. in Political Science from Middlebury College.
